## 2. Subject of the contract:

The subject of the contract is the **supply of long-range tactical-class communications** systems for environmental tests

INS must have the following parameters:

3-axis gyroscope

3-axis accelerometer

Gyroscope Angular Random Walk: less than 0.015 [degrees/sqrt(hour)]

INS Heading Accuracy: less than 0.02 deg

## 3. Order completion date:

The contracting authority requires that the order be completed within 60 days from the conclusion of the contract.

#### 4. Conditions for participation in the proceedings:

Contractors meeting the following conditions will be admitted to the proceedings:

1. No relationship between the Contractor and the Employer

A related Contractor is considered to be an entity:

- 1) related to or being a subsidiary, co-subsidiary or parent company in relation to the Contracting Authority within the meaning of the Accounting Act of September 29, 1994;
- 2) being an entity remaining with the Ordering Party or members of their bodies in such a factual or legal relationship that may raise reasonable doubts as to impartiality in the selection of a











supplier of goods or services, in particular remaining in a marital relationship, relationship of kinship or affinity up to and including the second degree, relationship of adoption, guardianship or custody, including through membership in the bodies of a supplier of goods or services;

- 3) being an affiliate or partner entity to the Contracting Authority within the meaning of Regulation No. 651/2014;
- 4) being an entity personally related to the Contracting Authority within the meaning of Article 32 (2) of the Law of March 11, 2004 on tax on goods and services

Evaluation of the fulfilment of the conditions for participation in the proceedings:

The Contracting Authority will evaluate the fulfilment of the above-mentioned condition by the Contractor according to the *meet/do not meet* formula on the basis of the statement submitted by the Contractor (Annex No. 2 to the Request for Proposal).

Failure to meet the above condition will result in the exclusion of the Contractor from the proceedings.

#### 5. Payment terms

The Ordering Party will pay an amount equal to 100% of the net order value to the Contractor's account on the basis of a correctly issued Proforma Invoice with a payment deadline of at least 14 days. After receiving the Payment from the Ordering Party, the Contractor will issue an Advance Invoice to the Ordering Party for the amount of the payment received.

After completing the delivery of the entire subject of the order, the Contractor will issue a final Invoice to the Ordering Party.

#### 6. Evaluation criteria:

The contracting authority will select the most advantageous offer on the basis of the following criterion: **Criterion name** 

weight % (W)

Net price 100

In terms of this criterion, the bid with the lowest net price will be the highest evaluated. Bids will be evaluated according to the formula:

Pcen=cmincnxW,

where: Pcen - number of points awarded in the criterion "Net price"

cmin - Net price of the cheapest bid submitted

cn - net price of the tested offer











#### W - weight of the criterion

The Contracting Authority will calculate the number of points awarded to two decimal places. The Contracting Authority will award the contract to the Contractor whose bid meets all the requirements set forth in the Request for Proposal and obtains the highest number of points (maximum 100 points).

#### 7. Method of bidding and required content:

Bids should be submitted in one of two forms:

- 1) The offer should be prepared in English on the attached form.
- 2) The bid should be signed by an authorized representative of the Contractor.
- 3) The bid price should be given in EURO currency to two decimal places.
- 4) Along with the Bid Form, send a signed *Declaration of no relationship between the Employer* and the Contractor.

## 8. Deadline for submission of bids:

Bids should be submitted no later than 03.04.2024 at 16:00 (GMT+1).

Bids submitted after the deadline will not be considered

#### 9. RODO information clause:

Pursuant to Article 13 (1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) (Official Journal of the EUL 119 of 04.05.2016 ,p.1), hereinafter referred to as "RODO", the Contracting Authority informs that:
